RELEASE AND INDEMNIFICATION AGREEMENT

IMPORTANT: Read carefully this form before signing. Your signature indicates your agreement.

I, individually and as the vessel's master (if indeed, I am the vessel's master), my boat's master (if other than boat's owner or operator), my team, the boat's crew and guests aboard agree and understand that the Custom Shootout, or any organization/firm that the Custom Shootout is part of or a division of, its/their directors, officers, employees and agents shall not be liable under any circumstances for any injuries or damages to person(s), be they physical injuries or otherwise, or property, arising out of, resulting from or in any way connected with my/our/my crew's participation in any tournament whether caused by or contributed to by any negligent act or negligent omission of the Custom Shootout or by any other reason or cause whatsoever. In consideration of the acceptance of me and my team and my crew entry and for other good and valuable consideration received, we hereby remise, release, and forever discharge the Custom Shootout and its respective heirs, executors, administrators, legal representatives, successors, assigns, or any firm/organization that the Custom Shootout is part of or a division of, its/their directors, officers, employees and agents of and from all claims, suits, obligations, liabilities, losses, damages, costs or expenses which our master, crew, owner(s), operator(s), team or guests aboard or their heirs, executors, administrators, legal representatives successors and/or assigns may have against the Custom Shootout, arising out of, resulting from, or in any way connected with my/our participation in any tournament. We understand that this release includes any claims based upon any negligent act or negligent omission of the Custom Shootout.

To the fullest extent permitted by law, I, individually and as the vessel's master (if, indeed I am the vessel's master), the boat's master (if other than the boat's owner or operator), my team and the vessel's crew and guests aboard hereby agree to indemnify, to defend with counsel acceptable to the Custom Shootout and to hold the Custom Shootout and its heirs, executors, administrators, legal representatives, successors, assigns, or any firm/organization that the Custom Shootout is part of or a division of, its/their directors, officers, employee and agents harmless from and against any and all claims, suits, obligations, liabilities, losses, damages, costs or expenses including but not limited to reasonable attorney fees suffered by the Custom Shootout or by any other person or persons whatsoever (including anyone for whose acts the Custom Shootout may be liable), regardless of whether it is caused by - or in part by - a party indemnified and held harmless hereunder, arising out of, resulting from, or in any way connected with my/our participation in any tournament.

All boats, owners, operators, masters, crews, guests and anglers will operate the vessels-and/or-fish at their own discretion and solely at-their own-risk.

This agreement shall take effect as an instrument under seal and be binding upon and inure to the benefit of me (individually and as master of the vessel, if indeed I am the master of the boat), my boat's master (if different than the owner or operator of the vessel), my team, the boat's crew and guests aboard, as well as the heirs, executors, administrators, successors and assigns of each.

Participants in the Custom Shootout are advised to obtain insurance covering themselves and their vessel's tournament participation.

My signature on this form, confirms my consent with the Release and Indemnification Agreement and also confirms that I have read and understand the *Rules* to the Custom Shootout.
